

2020 Clinic Survey Report



In the spring of 2020, Christian Legal Society surveyed our network of Christian Legal Aid (CLA) programs about their 2019 operations. Twenty-nine CLA programs responded to the survey. The following pages capture our findings on: Operations, Staff, Volunteers, Client Service, Faith Aspects, and Organizational Status.

- The oldest CLA program that responded to the survey started in 1997, with the median age of programs being 13 years old.
- The 29 CLA programs had a total of 92 clinic sites, constituting an average of 3 sites per program.
- Collectively, these programs served about 23,000 clients (including those who attended client legal seminars) across the country in 2019. The median number of clients seen by these CLA clinic sites was 253.
- Eighteen out of the 29 programs had paid staff in 2019. Most of those had 3 or less staff persons. The largest two programs had 11 and 37 staff. Eleven of the 29 programs rely solely on the dedication of volunteers. There was a wide range of sizes, ranging from just 1 to 130 volunteer attorneys, with the median at 15.
- Of the CLA programs that tracked service hours, in total they provided more than 11,700 hours of legal aid service in 2019. With a national median hourly billable rate of \$325¹, that amounts to over \$3,800,000 in donated legal services by Christian Legal Aid attorneys.
- As in the past two surveys, family law was the most common issue seen again in 2019, showing that
 domestic relations disputes are consistently a national problem.



CLA PROGRAM YEARS IN OPERATION

The oldest CLA program that responded to the survey started in 1997. The median age of the programs is 13 years old.



Number of Clinic Locations


NUMBER OF CLINIC LOCATIONS PER CLA PROGRAM


The 29 CLA programs that responded to the survey had a total of 92 clinics. Twelve programs operate out of one location. The average number of clinic locations is 3 per program. Program host sites include churches, other ministries to the poor, and even a local jail.

STAFF & CLINIC

NUMBER OF PAID STAFF

In 2019, 18 out of the 29 programs had paid staff (including attorneys and non-attorneys). Most of those had 3 or less staff persons. The largest two clinics had 11 and 37 staff. Eleven of the 29 programs rely solely on the dedication of volunteers.





TYPE OF CLINIC


More than half of the CLA programs are independent, incorporated 501(c)(3) entities. Five of the programs are divisions of a large nonprofit, and four are informally affiliated with another organization.


VOLUNTEERS

NUMBER OF VOLUNTEER ATTORNEYS

Almost all CLA programs (even those that have staff) depend heavily on volunteers to successfully serve their communities. There was a wide range of sizes in volunteer pools in CLA programs, ranging from just 1 to 130 volunteer attorneys, with the median at 15.



Number of Attorney Hours Served


ATTORNEY VOLUNTEER HOURS

Of the programs who tracked service hours, in total they provided more than 11,700 hours of legal aid service in 2019.

SERVING CLIENTS


FREQUENCY OF CLINIC SESSIONS

There was a wide range in how often CLA clinics met with clients. Generally, the ones with paid staff met more frequently, while volunteer programs met less frequently. But some volunteer programs meet several times a month and even weekly.



NUMBER OF CLIENTS SERVED

The number of clients served by CLA programs varied based on the size of the program. The largest ones served over 1,000 clients per year. (This includes short advice programs, intake meetings, as well as full representation.) The largest program served over 10,000 clients last year (includes client educational offerings).




Number of Clients Served



FAITH


Christian Legal Society's CLA network seeks to be an umbrella group of programs in which each program operates independently and makes its own decisions. All programs in the network view their legal aid work as a ministry to fulfill God's command to seek justice for the poor and the needy. Many of the programs encourage attorneys to speak about and share their faith. They have the incredible stories how the Lord changed the lives of those they helped.



EXTENT TO WHICH FAITH INFORMS CLA PROGRAM

Survey definitions:

5 - Faith-based: Faith is essential to what we do. We are overt about our faith basis and actively encourage attorneys and volunteers to pray with clients, provide spiritual advice, and evangelize.
3 - Faith-motivated: Faith is an important aspect of our work and we are open about our faith-motivation. It is up to our attorneys and volunteers how overtly they speak about faith with clients.
1- Faith-inspired: Faith forms the original basis of our work. We do not prominently advertise faith, nor actively pray, provide spiritual advice, or evangelize.



NUMBER OF PROGRAMS REQUIRING A STATEMENT OF FAITH


Half of the 24 CLA programs that responded to this question required that either their staff or volunteers adhere to a statement of faith. Five of the programs stated that they did have a statement of faith requirement, but it was generally understood that volunteers were of the Christian faith.

SERVICES PROVIDED

TYPES OF SERVICES OFFERED BY EACH CLA PROGRAM


Nearly all CLA programs provide general advice sessions to clients. More than half of the programs offer full representation, and about a third offer legal education trainings (such as "know your rights" seminars) to their

communities.



FREQUENCY OF ISSUES SEEN AT CLINICS

As in the past two surveys, family law was the most common issue seen again in 2019, with 17 out of the 29 CLA programs ranking it the number one legal issues seen in 2019. Immigration was a distant second, with 9 of the programs ranking it as the top issue. (The top issues in the "Other" category were guardianship and tax.)
